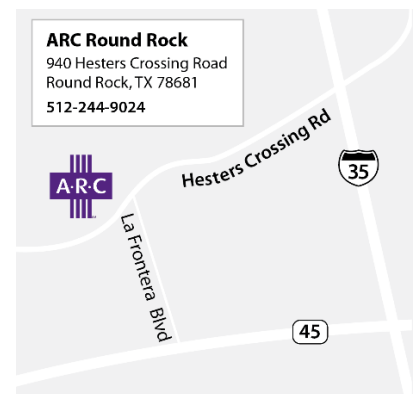
I am truly grateful to you for entrusting me with your health care and I hope to see you at my new ARC Round Rock location.
